**DATES:** *July 1, 2012; August 5, 2012; September 2, 2012; November 4, 2012; December 2, 2012; January 6, 2013; February 3, 2013; March 3, 2013; April 7, 2013; May 5, 2013.* **ALL MATCHES ARE ON SUNDAY**

**RULES:** Current NRA rules for approved tournaments will govern.

**ENTRIES LIMITED:** Entries will be limited to one relay of 15 competitors. Priority will be given to those firing the full 2700.

**FEES:** An entry fee of \$25.00 will be charged for the full 2700. Those firing 2 of the three matches will be charged \$20, 1 match \$15. There will be no charge for Juniors.

**SQUADDING:** All matches will be squadded. Squadding tickets will be issued at the range at the time of registration. Failure of a competitor to obtain his squadding tickets or to present himself at the proper firing point when relay is called may lose his right to compete in that event.

**SCORING:** Scoring will be by competitors in teams of two after each stage.

**CLASSIFICATION:** The NRA classification system will be used. Competitors without a valid classification card or Score Record Book will compete in the master class.

Classes: Separate class awards will be given.

1. If a class has less than 2 competitors, that class will be combined with the next higher class.
2. No class will be combined into the master class.
3. If the any class, including the master class consists of less than five competitors, awards will be given only for the aggregate Matches.
4. No class will be moved up more than one class.

**TIME:** First relay will be called no later than **8:30 AM**

**CHALLENGES:** A challenge fee of \$1.00 will be charged for each challenge made. See NRA rules for correct procedure
