NATIONAL RIFLE ASSOCIATION 2013 OPEN INTERNATIONAL FREE & STANDARD PISTOL SECTIONAL NATIONAL INDOOR PISTOL CHAMPIONSHIP

This competition is a **NRA Registered Match**. All regulations for registered matches will govern.

The 2013 NRA International Free & Standard Pistol Sectional National Indoor Pistol Championships are being fired at Sectional Tournaments throughout the United States. All local challenges and protests are to be resolved on the match site according to procedures outlined in Section 16 of the NRA Inter Pistol Rule Book. Each individual competitor and team firing in a Sectional will automatically be entered in the National Championship at no additional cost. **Note:** All fired target must be retained by sponsor two weeks after the published national bulletin.

Rules: Current NRA International Pistol Rules.

Competition Open to: All competitors. Individual or team may enter only one NRA International Free & Standard Pistol Sectional during 2013. Membership in the NRA is encouraged but not required in order to participate in this match. Tournament officials may not compete in the Sectional at which they are officiating.

Teams will consist of three (3) firing members as defined in Section 2. **Team members must be designated before the individual matches commence. The individual match score will be used for the team score. The team match is not a fired match.**

Entry Fee: NRA Sectional Registration Fees include entry into the 2013 NRA Indoor Pistol Championships.

Individual Matches: One Match \$15.00 per competitor.
Two Matches \$25.00 per competitor.

Team Matches: \$12.00 per team, each match (**team matches are not a fired match**).

Individual Entries: Entries will be made by submitting the enclosed Registration form with check or money order. Be sure to write your current NRA International Classification and NRA Membership number.

Entries Close: Advance individual match entries must be received no later than **Sunday, 3 March 2013**. Team entries must be made prior to the start of any team member's firing in the individual match.

Post Entries: No post entry fee will be charged.

Competition Capacity: Match is limited to 28 competitors per match (28 Free and 28 Standard). Entries will be accepted up to limit. Entries received after limit will be returned.

Firing Starts: **Free Pistol:**

1st Relay: 8:00 – 10:00 AM **2nd Relay:** 12:00 – 2:00 PM

Standard Pistol:

1st Relay: 10:30 – 11:30 AM **2nd Relay:** 2:30 – 3:30 PM

Distance: 50 Feet.

Targets: NRA Official: Free Pistol B-11, Standard Pistol B-33.

Schedule & Course of Fire: **Match No. 1 - Free Pistol:** Unlimited sighters and sixty record shots in 120 min. Fired in 7 series, 17 min per series. 1st series unlimited sighters, series 2-7, 10 shots per target.

Match No. 2 - Standard Pistol:

Sighting Shots: 5 shots fired in 150 sec.

Slow Fire Stage: 20 record shots in 4 series, 5 shots fired in 150 sec. ea. series.

Timed Fire Stage: 20 record shots in 4 series, 5 shots fired in 20 sec. ea. series.

Rapid Fire Stage: 20 record shots in 4 series, 5 shots fired in 10 sec. ea. series.

Match No. 3 Free Pistol Team, (team match is not a fired match).

Match No. 4 Standard Pistol Team, (team match is not a fired match).

Pistol: Free Pistol: Per NRA International Pistol Rule 3.6.

Standard Pistol: Per NRA International Pistol Rule 3.5.

Challenges: A challenge fee of \$1.00 will be charged for each challenge made.

Classification: The NRA International Pistol Rules, Section 19-Classification, shall govern for both individuals and teams. Each competitor must exhibit a valid classification card or Temporary Score Record Book prior to the start time. Unclassified competitors will fire in the Master class

Category: Open, Woman, Junior, Junior Woman, Senior, and Grand Senior.

Souvenir Award: NRA will provide a participation pin for each competitor.

NRA Sectional Awards: Schedule will be posted on site.

Local Individual Awards: 1st, 2nd & 3rd place NRA Sectional Award winners are not eligible for local individual awards.

Award Points (AP) will be given to the high scoring competitors in each class (Master, Expert, Sharpshooter, and Marksman).

1st Place, 7 AP, there must be a minimum of 3 competitors in class, except for Master.

2nd Place, 5 AP, 5 or more in a class.

3rd Place, 3 AP, 8 or more in each class.

Competitors will be moved up to the higher class to achieve the minimum.

Local Team Awards: Award Points (AP) will be given to the high scoring teams.

1st Place, 9 AP

2nd Place, 6 AP, 4 teams minimum.

3rd Place, 3 AP, 8 teams minimum.
